Knight (of Driscoll & Knight) appeared in connection with expected visit to Edmonton of Engineers Fraser, Mountain and Dunn re subways and suggested that the question of Union Railway Terminals be taken up with them by the City authorities. Mr. Knight presented sketch of proposed Union Station at corner of 109th Street and Jasper Ave. for information of Council.
