Bylaw 7149 - to amend Bylaw 6869 being a Bylaw providing for the Assessment and Taxation of Business carried on with the City of Edmonton.

RECOMMENDATION:

That City Council approve a revision to the Business Tax Fiscal Policy, as outlined in Enclosure II.

## HISTORY

In order to provide a guideline for the equitable distribution of business and property taxes, having regard for the conditions set out in the Municipal Taxation Act, City Council approved the Business Tax Fiscal Policy as outlined in Enclosure II. The Policy provides for a method of allocating the municipal expenditure level as adopted by City Council between business and property tax. In accordance with the Policy, Business Tax Rates are adjusted annually.

On 1982 08 10, City Council approved the 1982 Business Tax Rates (Bylaw 6969) in accordance with the Policy. The increase in property tax approved for 1982 was significantly lower than anticipated when the 1982 Business Tax Bylaw was approved and would have resulted in a substantial credit in 1983. On 1982 05 25, City Council therefore approved a business tax refund of approximately \$4 million in advance of the policy refund to ensure that the funds were available to businesses in the City as expeditiously as possible.

At the 1982 04 27 meeting of City Council, the following motion was concurred in:

"that there be a review of the Business Tax Fiscal Policy and that the matter be referred to the Administration for review".

At the regular meeting of the Corporate Resources Committee (Current Budget Meeting No. 7) held 19823 01 20, the following motion was concurred in:

"That City Council approve a revision to the Business Tax Fiscal Policy, as outlined in Enclosure I.

That City Council approve the 1983 Business Tax Rates as outlined in Bylaw 7149 (Enclosure I)."

## JUSTIFICATION.

1. Since Council has approved a budget guideline for 1983 and, due to the accelerated 1983 budget process, business and property tax rates can now be set at the same time which will eliminate the need for any future adjustment.

The revised business tax policy will set the business tax rate in a manner so that the increase in the business tax levy will be in the same proportion as the increase in property tax.

2. These rates are based on Council's approved mill rate guideline of an 8% increase from 1982 - 1983. It is not anticipated that there will be any refunds/adjustments, assuming that the City Council guideline is adhered to in 1983. The 1983 business tax rates will increase by about 1.4% over the 1982 revised rates. (See Enclosures III and IV).

This will result in an average 8% business tax increase in 1983, similar to the 1983 8% property tax increase. However, there will be variations from the average business tax increase due to changes in the assessed value which takes into consideration rental value increases and physical additions to individual business premises.

# PURPOSE

The purpose of this Bylaw is to set the 1983 Business Tax Rates in accordance with legislative requirements and the revised Business Tax Fiscal Policy.

Bylaw No. 7150 - Property Tax Mill Rate Bylaw, a Bylaw Authorizing the Levy of Tax Upon All Assessed Property Shown on the Assessment for the Year 1983

## HISTORY

At the Corporate Resources Committee meeting (Current Budget Meeting No. 7) on 1982 01 20, the following motion was concurred in:

That the 1983 Mill Rate Bylaw be given First and Second Reading by City Council.

City Council each year as part of the budget process and as required under the Municipal Taxation Act must approve the Mill Rate Bylaw.

City Council has directed the Administration to limit the 1983 Mill Rate to an eight percent (8%) increase for Municipal purposes.

In addition to providing a mill rate for municipal purposes, City Council must include Mill Rates recognizing official requisitions received from School Boards and from the Province pursuant to the School Act.

## JUSTIFICATION

The Bylaw is required to authorize the 1983 mill rates for property tax in accordance with the Municipal Taxation Act, Revised Statutes of Alberta, 1980, Chapter M-31.

The 1983 budget process is in the final approval stage and it is necessary that both the mill rate and business tax rate be set at the same time to ensure equitable treatment for both types of taxpayers.

The requisition from the School Boards and the School Foundation requisition from the Province have not been received and therefore and estimated mill rate increase of 8% similar to municipal mill rate has been used.

The Mill Rate Bylaw will be adjusted when the final information is received and will then be presented to City Council for final reading and approval.
