- (f) **"Ticket"** means a ticket permitting the holder to admittance to a Stadium Event;
- (g) "**Ticket Price**" means the actual price paid by the initial purchaser of a Ticket, excluding complimentary tickets, exclusive of Goods and Services Tax.

PART II - ADMISSION SURCHARGE

| 4 | Commencing January 1, 2012, every Ticket for a Stadium Event shall be subject to the Admission Surcharge. |

| 5 | All vendors of Tickets shall collect the Admission Surcharge as the agent and trustee of the City of Edmonton and shall promptly pay the same to the City without deduction or set off. |
| 6 | The City may enter into agreements with vendors of Tickets dealing with collection and remittance of the Admission Surcharge, accounting, auditing, and related matters. |
| 7 | The Admission Surcharge is being collected for the purpose of recouping the capital cost of seat replacement at Commonwealth Stadium and shall only be collected until such time as the capital costs of the seat replacements has been fully recovered. |
