BYLAW 19045

A Bylaw to amend Bylaw 15238, to authorize the City of Edmonton to acquire, implement, and finance Transportation Project, LRT Signal System

WHEREAS:

The Council of the City of Edmonton on July 22, 2009 duly passed Bylaw 15238, authorizing the City of Edmonton to acquire, implement, and finance Transportation Project, LRT Signal System ("Project"), and also authorizing the Mayor and Chief Administrative Officer to borrow the sum of \$9,934,000.00 for a period of twenty-five (25) years with the principal and interest to be repaid in semi-annual or annual instalments;

It has now been determined that the Project, 09-66-1296 LRT Signal System, is completed with a total cost of \$30,963,612.00. The borrowing authority will therefore be decreased by \$137,162.00 from \$9,934,000.00 to \$9,796,838.00;

THEREFORE, THE COUNCIL OF THE CITY OF EDMONTON DULY ASSEMBLED ENACTS AS FOLLOWS:

1. Bylaw 15238 is amended in the preamble, paragraph two, thereof by deleting the figure "\$29,800,000.00" as it appears and by substituting the figure "\$30,963,612.00".

2. The said Bylaw is further amended in the preamble, paragraph four and Sections (1) and (2), thereof by deleting the figure "\$9,934,000.00" as it appears and by substituting the figure "\$9,796,838.00".

- 3. The said Bylaw is further amended in the preamble, paragraph five, thereof by deleting the words "2009-2011 Capital Budget" as it appears and by substituting the words "2009-2011 Capital Budget and 2012-2014 Capital Budget".
- 4. The said Bylaw is further amended in the preamble, paragraph seven, thereof by deleting the date "December 31, 2008" and the amount of "\$1,232,741,601.65" for the existing debt of the City of Edmonton as it appears and substituting the date "December 31, 2018" and the figure "\$3,046,193,851.11".
- 5. The said Bylaw is further amended by replacing Schedule "A" with Schedule "A" as attached.

6. This Bylaw shall take effect on the day of the final passing thereof.
